## Message from the Director

This is our first full year of operation as the Legal Resource Centre and we are pleased to report a very successful year. Along with our regular programming, the LRC staff worked on nine projects. As a result, our staff has increased to 12, with 2 more vacancies still to be filled as of June.

Our ongoing programs experienced continued growth, showing an increase of 34% in visitors to our websites and a growth of 66% in our information and referral services. A similar increase in research and publication, as well as in public presentations, made for a busy and exciting year.

One of our most rewarding initiatives was the Canadian Law for Modern Day Foreign Brides website. Launched In March of 2008 in time for International Women's Day, the website was created in collaboration with Changing Together: A Centre for Immigrant Women, a non-profit organization run by immigrant women for immigrant women which aims to breakdown personal and systemic barriers so that women may fully participate in Canadian society. Funding for this important project was provided by the Alberta Law Foundation.

The added space in our new facility meant that we were able to undertake another important initiative. With support from the Sandra Garvie Memorial Fund, we were able to unpack the public legal education library which had been dormant for some time. The library contains PLE materials back to the 1980s and is an excellent research collection. In the upcoming year, we will begin to add new materials to the collection and will have an online catalog searchable by all PLE providers.

## Access to Justice Network

ACJNet is Canada's access to justice portal. It serves as a clearinghouse of electronic resources that address a myriad of legal and justice matters. It includes sub-portals dealing with resources of particular interest to Albertans and with those available in French.

### Highlights

- Staff responded to over 900 public queries, an increase of 66%. The most popular topics continue to be landlord/tenant, labour/employment, and marriage/family.
- Six electronic newsletters were sent out to 200 subscribers.
- An electronic version of *Women and the Law in Alberta* developed by the Calgary Women Lawyers group was posted to ACJNet.
- Special topics resources were developed on Rent Controls, Grandparents Rights, Canadian Security, Dual Citizenship, Internet Safety, and Gangs & Gang-Related Crime in Alberta.
- RSS feeds were added to ACJNet National, Alberta, and Français.
- Six polls were run on ACJNet and ACNetAlberta.
- Over 10,000 live records are now in the ACJNet database.
- Close to 200 events were added to the ACJNet listings.
- Over 200 new websites and/or resource links were added.
- Over 1000 news items added to ACJNet, ACJNetAlberta, and ACJNetFrancaise.
- About 50 new websites or PLE services were featured on each of the three sites.
- Visitors to the site came from 142 different countries.

## A-Link: Alberta's Law-related Information Network

Jointly funded by Alberta Justice and the Alberta Law Foundation, A-Link is a searchable, online directory of public legal education and information organizations in Alberta. The online directory contains standard directory information, along with descriptions of services and programs offered; geographical areas served; and contact information. It also features a glossary, ensuring users are able understand legal terms they come across. The directory also has a members-only component where organizations can update their records and add information.

A-Link includes information about 269 organizations and agencies that provide legal information or services to the Alberta public. Its interactive map allows users to easily search for organizations in their region. Alberta Justice has provided funds to develop a print feature that will allow organizations to print off copies of directory listings by topic or geographical location.

## Canadian Legal FAQs

Canadian Legal FAQs provides short, clear answers to legal questions related to provincial law and to federal law applicable to Albertans.

### Highlights

- The website underwent a major renovation transferring the content to a Wiki format.
- The new site provides easier access to the French language version of questions.
- During the year, 162 new or revised FAQs were added to the site, with another 153 in development.
- New topics included wills, power of attorney, personal directives, labour and employment, and temporary foreign workers.
- The site received over 320,000 visitors, an increase of 22% over the previous year.
- Visitors read an average of 7.7 pages when they came to the site.

## Residential Tenancies

The Residential Tenancies program is funded by the Alberta Real Estate Foundation (AREF). During the year, staff continued to concentrate on promotion and training initiatives. These initiatives were geared towards various sectors of the real estate industry and public legal education. Public libraries were specifically targeted.

### Highlights

- The number of visitors to the site doubled from the previous year to over 310,000.
- Over 7500 items were mailed out to Albertans. Several thousand more were handed out at seminars and conference conducted to train both the public and intermediaries on how best to use the web resource.
- Over 400 questions were answered from site users. New FAQs were created if the questions were repeated frequently.
- The website was regularly updated to adjust for changes in regulations.
- Awarded an Alberta Consumer Champion Award of Distinction by Service Alberta in conjunction with the Alberta Real Estate Foundation.

In 2000, a Legal Studies Program study found that the relationship between landlords and tenants would be improved if more educational resources were available. The Alberta Real Estate Foundation agreed to fund a web-based learning resource. The result is <http://www.landlordandtenant.org/> - an easy-to-use website with more than 1,000 pages of user-friendly information about renting a home in Alberta... It is the only website of its kind in Canada.




The wide range of materials includes:

## LawNow

**LawNow** strives to provide credible legal information, interpretation, and comment to help Canadians understand the law and its relation to everyday life. The publication team includes lawyers, writers, law librarians, educators, and editors. We are grateful to our contributors (over 45 lawyers and other professionals) who supported **LawNow** by article and column contributions.



### Highlights

- Subscriptions and renewals can now be done online through PayPal.
- Topics covered in this year included environmental law, the *Charter*, consumer law, equity law, and citizenship.
- Copies were distributed at Law Day in Vancouver and Victoria, as well as around Alberta, at the Canadian and Alberta Library Conferences, as well as at conferences of the Alberta Mediation Society and the Seniors Association of Greater Edmonton.
- **LawNow** articles were reprinted by High Beam Encyclopedia, Ontario Ministry of Education, the Max Plank Institute in Germany, Philosophy 201 course at Camoson College, the Senate at McMaster University, and Cengage Learning.
- **LawNow** participated in RAMM (Read Alberta Magazines Month), a promotional blitz coordinated by the Alberta Magazine Publishers Association.
- **LawNow** bounce rates are only 12%, which means that site visitors stay to use the site. The average user stays on the site over 9 minutes and looks at an average of 9 pages of information.
